The Township of Douro-Dummer is requesting quotes for the removal and replacement of an existing septic system, and the installation of a frost protected potable water tank for the Douro Fire Station at 435 Fourth Line of Douro. The new septic system will include a pumping station, piping and a new septic bed as per Part "C".

A building permit has already been issued for this project.

Part "B"

Amendments to "Standard Terms and Conditions"

Where Amendments to the Township's "Standard Terms and Conditions" are contained herein, it should be noted that these Amendments supersede any of the foregoing Terms and Conditions.

1.0 Submission Requirements:

All submissions must comply with Ontario industry best practices, Ontario Building Code, and the Ministry of the Environment. The installer shall be qualified as per Ontario requirements.

The successful bidder will be required to submit proof of Workplace Safety Insurance Board (WSIB) coverage, within ten (10) working days of receiving the Acceptance Notice and shall provide additional certificates as often as is deemed necessary by the Township during the term of the contract to ensure continued good standing with WSIB.

or

The successful bidder shall provide proof to the Township from the WSIB that the bidder does not require WSIB insurance. If the successful bidder changes its status with the WSIB during the term of the contract such that coverage is required, the successful bidder shall immediately provide the Township with the WSIB Clearance Certificate.

Bid Closing Time

One copy of the submission, or as otherwise requested herein, properly signed and sealed and clearly marked as to its contents, shall arrive at the Municipal Office, 894 South Street, PO Box 92, Warsaw, ON KOL 3AO no later than the specified time and closing date indicated on the cover page of the document.

Late bids shall not be accepted

The time registered on The Township of Douro-Dummer's front counter computer clock will be considered the official time when determining exact time of submission.

Pricing Requirement

Prices shall be in Canadian Funds, broken down for each item stipulated F.O.B. the point specified therein.

All prices bid shall include applicable taxes, customs duty, excise tax, freight, insurance and all other charges of every kind attributable to the work. Harmonized Sales Tax shall be shown as extra, unless otherwise specified.

In the event of any discrepancy between the unit price and the extension, the unit price shall govern.

Septic and Potable Water System

Delivery

All bids shall be F.O.B. Destination, 435 Fourth Line of Douro. The Company shall be responsible for arranging its work so that completion shall be as specified in the contract.

Contract Award

The Township reserves the right to award by item, or part thereof, groups of items, or parts thereof, or all items of the bid, and to award contracts to one or more bidders submitting identical Bids as to price; to accept or reject any Bids in whole or in part; to waive irregularities and omissions. If in so doing, the best interests of the Township will be served. No liability shall accrue to the Township for its decision in this regard.

The lowest or any bid may not necessarily be accepted as the Township of Douro-Dummer reserves the right to reject any or all bids. Bids shall be irrevocable for forty five (45) days after the official closing time and the Township may at any time within that period without notice, accept a Bid whether any other Bid has been previously accepted or not.


Part "C" Designed System


The certified underground potable water poly-tank will be approximately 1500 gallons.

A 16" high armour stone wall between the parking lot and water tank area should be included in the bid, but separated in pricing as a provisional item (depending on finishing grade this wall may or may not be required).

Connections to building must be completed for both septic (existing) and water tank (new) in coordination with the Township plumber. Plumbing connections will be paid direct to the Township plumber and are not to be included in this proposal.

All tanks will be backfilled with a minimum of 6" of topsoil finishing grade. All disturbed areas will be grade finished and grass seeded, unless part of the gravel compound area, then no grass seed is required. The raised septic bed will be graded and grass seeded to prevent erosion as per design.
