

Recommendation:

That the report Treasurer-2026-04, dated February 17, 2026, regarding the 2025 Statement of Remuneration and Expenses paid to Members of Council and Local Boards (Municipal Act, 2001, s. 284) be received for information.

Overview:

Under Section 284 of the Municipal Act, 2001, the Treasurer of a township shall in each year on or before March 31 provide to the Council of the township an itemized statement on remuneration and expenses paid to members of council and local boards.

Council remuneration reported herein is provided in accordance with Township By-Law 2022-37 – Council Remuneration, including the annual adjustment effective January 1 of each year.

- 1.) The 2022 base honorarium rates per year for members of Council as set out in the By-law are:

Mayor	\$32,403.17
Deputy Mayor	\$24,566.16
Councillors	\$21,995.44

And are subject to increases on January 1 of each year.

Bringing the 2025 honorarium rates per year to:

Mayor	\$36,982.40
Deputy Mayor	\$28,038.40
Councillors	\$25,105.60

- 2.) Benefits include Township paid statutory payroll costs such as Canada Pension Plan (CPP) and Employer Health Tax (EHT) as well as applicable insured benefits premiums.
- 3.) Expenses include reimbursements and Township paid costs related to conferences, training and travel.
- 4.) The period covered by this report is January 1, 2025 – December 31, 2025.


In accordance with s. 284 of the Municipal Act, 2001, this statement is a public record and is required to be made available to the public.
