6.0 Purpose/Reason of the Application

Please describe the proposal and explain why it is not possible to comply with the zone provisions/standard set out in the Township’s Zoning By-law. (If additional space is required, please attach a separate sheet)

Proposal is to construct a garage; no demolition of existing structures required. We are seeking relief of Zoning By-Law 2010-55, Section 3.1.2, that states "no accessory building or structure may be located within 15 metres of any lot line abutting a street or private road". Proposed garage would be setback 10.5 metres from street lot line; we are seeking 4.5 meters relief. Meeting the 15 metre setback would place the proposed garage within ORCAs regulated area, and would place the garage too close to the existing dwelling, which would prohibit vehicle access to the area of property behind the proposed garage via the existing driveway, such as allowing lawnmower access to the area behind the garage.




